Named after the legendary aircraft designer Clarence "Kelly" Johnson, the award is one of the highest distinctions in the global flight test community. Dr. Maris was nominated by the **SFTE Canadian Chapter**, with widespread support from international flight test professionals.

Over a career spanning more than 35 years, Dr. Maris has made groundbreaking advancements in human factors, flight safety, and aviation efficiency. As Principal Flight Test Investigator and test pilot at NASA, he advanced human factors, flight efficiency, and safety through projects like Traffic Aware Strategic Aircrew Requests (TASAR) and NASA's Digital Flight workframe. His work involved understanding the safe conduct of flight tests, integrating them into real-world air traffic control, and analyzing human factors in new operating modes. His extensive portfolio includes over 20 aerospace patents, including award-winning innovations in airfoil performance monitoring. Beyond his technical contributions, Dr. Maris has been instrumental in the development of synthetic vision systems, human factors research in icing conditions, and autonomy in electrified and hybrid-electric flight. He currently serves as Chief Test Pilot for CAE's Piper Archer electric trainer and Pratt & Whitney's Hybrid Electric Propulsion programs.

"John's legacy is one of innovation, mentorship, and dedication," said Alistair Chapman from Certification Center Canada. "He exemplifies the mission and values of 3C—pushing the boundaries of what's possible in aviation, while uplifting the next generation of engineers."

In addition to his technical and flight test work, Dr. Maris is a passionate mentor, known for supporting young engineers and fostering careers in aerospace. He is an active SFTE member, frequently presenting at international symposiums and contributing to Chapter activities.
